S. A., Canada, Australia, New Zealand, South Korea, Japan, Hong Kong, Macau, and Taiwan. This insurance product does not apply to any accident occur during the war (whether or not declared), military action, insurrection, rebellion or revolution.

◆71至80周岁的被保险人, 其“人身意外身故、残疾”的保险金为上述所载保险金额的一半, 保险费维持不变。For any insured person age from 71 to 80 years old, half maximum limit under “Accidental Death / Disablement” and the premium remains unchanged.

Every insured person will have a travel insurance (including air aviation accident insurance) products for the same trip only in Huatai Property Insurance. The indemnity provided by this Policy does not apply to any insured who has been diagnosed with AI, or been suspected of being infected with AI, or been asked to be isolated by the Department of Health because of AI before the insurance application.
